Vide paper (1) read above, the University had invited applications from affiliated colleges for granting Provisional Affiliation for the academic year 2025-26.

In response to the above notification, the Principals of 8 medical colleges mentioned in Table A submitted their applications for granting Consent of Affiliation for the starting/enhancement of seats in PG courses for the academic year 2025-26, vide paper (2) read above.

University had conducted an inspection and the reports submitted by the Inspection Commission were scrutinized by the Scrutiny Committee and recommended to grant Consent of Affiliation for the



starting/enhancement of seats in PG courses, vide papers read (3 & 4) above.

Accordingly, the University issued Consents of Affiliation to the above mentioned medical colleges for the starting/enhancement of seats in PG courses for the academic year 2025-26, vide paper (5) read above.

Vide paper (6) read above, on receipt of the Letter of Permission from the National Medical Commission, the Principals of the above mentioned colleges submitted applications for Provisional Affiliation for the starting/enhancement of seats in PG courses for the academic year 2025-26.

Vide papers (7 & 8) read above, the University has conducted final inspections at these colleges, and the reports of the Inspection Commission received from the institutions were scrutinized by the Scrutiny Committee. The Scrutiny Committee has recommended granting Provisional Affiliation for the starting/enhancement of seats in PG courses with the intake mentioned against each, as shown in the table below, for the academic year 2025-26.

Since the names of the medical colleges had to be urgently forwarded to the CEE and DME for allotment process, the Hon'ble Vice Chancellor, based on the recommendation of the Subcommittee of the Governing Council, granted provisional affiliation for starting/ enhancement of seats in PG courses

Accordingly, the University forwarded the names of the medical colleges to the CEE and DME for considering these colleges in the allotment process for the academic year 2025-26.

The matter has been placed before the 88th meeting of the Governing Council and the Governing Council has resolved to ratify the action of the Hon'ble Vice Chancellor in having granted Provisional Affiliation for starting/Enhancement of seats in PG courses in above mentioned medical colleges and forwarding the same to DME/CEE, vide paper read (10) above.

Accordingly, orders are hereby issued granting Provisional Affiliation for the starting/enhancement of seats in PG courses with the intake mentioned against each to the medical colleges for the academic year 2025-26.

In addition to the above, the college shall satisfy the conditions detailed below:

- Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2025-26. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- Admission to the next academic year shall be done only after obtaining prior permission from the University. The College should collect fees (one-time payment at the time of admission) from the students to be remitted to the University as follows:

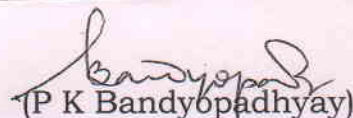

This shall be a recognized medical qualification when granted by **Kerala University of Health Sciences, Thrissur** in respect of students being trained at **Al-Azhar Medical College & Super Specialty Hospital, Thodupuzha** with annual intake of 150 MBBS students on or after **February, 2019**.

- Note: 1. The recognition so granted to an undergraduate courses for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
2. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.
3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned undergraduate Course.

In the circumstances, orders are issued ratifying the action in having granted Continuation of Provisional Affiliation to above said Medical Colleges for conducting medical UG, PG and Super speciality courses against the intake mentioned each for the academic year 2025-26 and forwarded the same to DME/CEE .

In addition to the above, the college shall strictly adhere to the conditions detailed below :-

- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Hon'ble Supreme Court of India in writ petition (C) No.656/1998, the Institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2025-26. The colleges have to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with copy of the letter of approval from apex bodies concerned.
- The colleges should remit annual administration fee fixed for UG / PG courses for the academic year 2025-26, if applicable.
- The College shall produce the orders regarding the constitution of College Council for the academic year 2025-26 during the time of student data verification.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
